

NOTICE OF CREDENTIAL USE CONDITIONS

DAY OF GAME - JANUARY 8, 2024

This credential is issued by CFP Events, Inc. to qualified individuals for the sole purpose of, and as consideration for, providing limited access to NRG Stadium on January 8, 2024, in connection with the College Football Playoff National Championship. By accepting the credential, the bearer agrees for himself/herself and for his/her organization that he/she has read this credential and understands and agrees to abide by all the following terms and conditions:

- 1. Working access:** This credential is issued for official business use only, subject to the restrictions described herein. Non-working personnel and/ or anyone without a credential are not permitted in any working areas. This credential grants bearer access to NRG Stadium located in Houston, Texas ("Stadium"), itself, field and media areas.
- 2. Adult use only:** This credential is not valid for any individual under the age of 18.
- 3. Display of credentials:** This credential must always be worn in plain sight with the appropriate corresponding lanyard color.
- 4. Non-transferable:** This credential is for use only by the approved individual and cannot be duplicated or transferred. Any unauthorized use of this credential subjects the bearer to ejection from the Stadium, possible prosecution for criminal trespass and possible loss of credentials for future College Football Playoff events.
- 5. Right to revoke:** CFP Events Inc., CFP Administration, LLC, the College Football Playoff Foundation (collectively, "CFP"), the conferences and institutions comprising the College Football Playoff, and the Stadium owner reserve the right to revoke this credential if it is improperly used, as determined in the aforementioned entities' sole discretion. Any photos or postings of this credential on social media sites will result in the immediate revocation of this credential. All credentials remain the property of the CFP and must be surrendered upon request.
- 6. Sideline restrictions:** Persons with sideline access must remain behind the limit line located 12 feet from the sideline and outside the team bench areas.
- 7. Media rights:** This credential authorizes the member of the media bearing it and the member's organization to use the accounts, photographs, drawings, video, audio recordings, or other information captured in connection with the College Football Playoff National Championship solely for traditional news and editorial coverage. Any other use or attempted use (including but not limited to non-editorial, advertising, sales promotion, licensing or merchandising) is strictly prohibited without the prior specific written consent of CFP.
- 8. IMPORTANT: INDEMNITY, ASSUMPTION OF RISK AND WAIVER OF CLAIMS:** By using this credential, the bearer and the bearer's organization acknowledges that use of this credential and attendance at the College Football Playoff National Championship involves risk of personal injuries, illness, death, and/or damages to property related to the performance of his/her services and attendance at the College Football Playoff National Championship. Without limiting the foregoing, attending the College Football Playoff National Championship on the field is inherently dangerous and involves significant risk of injury, illness, or death to the bearer caused by hazardous weather, the presence of infectious disease, adverse maintenance conditions, or the presence, movement, or traffic of crowds. The bearer and the bearer's organization each acknowledge, understand and

agree that CFP would not grant this credential unless they each voluntarily and with full knowledge of the risks expressly accept and assume full and complete responsibility for any and all risks and dangers of personal injury (including death), illness, infection, property loss, theft, or damage, and all hazards arising from or in any way related to the use of this credential and agree to the succeeding release, waiver, and indemnity. In consideration of the Credential, the sufficiency of which the bearer hereby acknowledges, the bearer agrees to the succeeding release, waiver, and indemnity. The bearer and the bearer's organization, to the fullest extent permitted by law, hereby expressly (a) release, waive and otherwise hold the Released Parties (as defined below) harmless against such risks, and (b) indemnify and covenant not to sue, ESPN Inc., CFP, the conferences and institutions that participate in the College Football Playoff, USA Football, Harris County-Houston Sports Authority, City of Houston, Houston First Corporation, SMG, ASM Global, Harris County, Harris County Sports & Convention Corporation, Houston NFL Holdings, LP., Houston Livestock Show and Rodeo, Inc., Michael T. Fiur Productions, Inc., and their respective affiliates and officers and directors, or any subdivision thereof, and any of the aforementioned entities' respective affiliates, members, subsidiaries, employees, officers, directors, representatives, agents, volunteers, successors, and assigns (collectively referred to as the "Released Parties"), for any and all claims, losses, liabilities, costs, expenses, demands, rights, indemnities, causes of action, and suits in equity of whatever kind or nature (collectively, "Claims"), including without limitation, Claims arising from illness, injury, death, or property loss or damage, arising from, or in any way related to, the bearer's presence or participation in any services or activities at the Stadium whether caused by the Released Parties' negligence or otherwise, to the fullest extent permitted by law.

As a condition of admission to the College Football Playoff National Championship, the bearer consents to questioning, infection screening, or physical searches of its person or property and confiscation of prohibited items, and agrees to observe all requirements for entry, including, without limitation, the wearing of masks or face coverings.

- 9. Other restrictions:** No firearms or weapons are permitted at the Stadium. The bearer of this credential may not solicit contributions, conduct polling, or distribute literature at the Stadium. The bearer of this credential hereby grants the Released Parties and its designees an irrevocable, perpetual, royalty-free, worldwide, unlimited and unrestricted license to use the bearer's picture, voice, likeness or name in any broadcast, telecast, print media, promotion or other means on account of any of the CFP events for any lawful purpose whatsoever, without compensation or any right of approval. The bearer agrees not to take any action, or cause others to take any action, which could infringe upon the Game Group's rights. The bearer shall not use the trademarks of CFP, including but not limited to the College Football Playoff logo and the College Football Playoff National Championship Trophy logo, without CFP's expressed written consent. The bearer may not interfere in any way with the play of the contest or any other aspect of the event or its telecast.

THE BEARER OF THIS CREDENTIAL HAS READ AND FULLY UNDERSTANDS THESE TERMS AND UNDERSTANDS THAT HE/ SHE IS GIVING UP SUBSTANTIAL RIGHTS, INCLUDING HIS/HER RIGHT TO SUE. THE BEARER OF THIS CREDENTIAL ACKNOWLEDGES THAT HE/SHE IS AGREEING TO THESE TERMS FREELY AND VOLUNTARILY AND INTENDS BY ITS ACCESS TO THE STADIUM FOR THIS TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.

GAME WEEK - JANUARY 1-9, 2024

This credential is issued to qualified individuals for the sole purpose of, and as consideration for, providing limited access to CFP Venues and Events on January 1-9, 2024 in connection with the College Football Playoff National Championship. By accepting the credential, the bearer agrees for himself/herself and for his/her organization that he/she has read this credential and understands and agrees to abide by all the following terms and conditions:

- 1. Working access:** This credential provides working access only. Non-working personnel are not permitted in any working areas or on the sidelines.
- 2. Adult use only:** This credential is not valid for any individual under the age of 18.
- 3. Display of credentials:** This credential must always be displayed prominently with the appropriate corresponding lanyard color.
- 4. Non-transferable:** This credential is for use only by the approved individual and cannot be duplicated or transferred. Any unauthorized use of this credential subjects the bearer to ejection from any venue operating in connection with the College Football Playoff National Championship events, possible prosecution for criminal trespass and possible loss of credentials for future College Football Playoff events.
- 5. Right to revoke:** This credential may be revoked at any time at the sole discretion of the CFP. Any photos or postings of this credential on social media sites will result in immediate revocation of this credential. All credentials remain the property of the CFP and must be surrendered upon request.
- 6. Media rights:** This credential authorizes the member of the media bearing it and the member's organization to use the accounts, photographs, drawings, video, audio recordings, or other information captured in connection with College Football Playoff National Championship events solely for traditional news and editorial coverage. Any other use or attempted use (including but not limited to non-editorial, advertising, sales promotion, licensing or merchandising) is strictly prohibited without the prior specific written consent of the issuer.

By way of example and not limitation of the foregoing, the bearer confirms that they are fully aware, understand and agree that attendance at College Football Playoff National Championship events is inherently dangerous and may cause injury; unauthorized entrants may cause disruptions and/or injury; the presence of or performance by a mascot may cause injury; any theft, battery, or similar crime by an attendee may cause injury; the presence of infectious disease, including COVID-19, may cause injury or death; motorized vehicles will be operating at all times and may cause injury to the bearer; amusements and entertainment may cause injury; any rushing of the field by authorized ticket holders that may cause injury; animals involved in entertainment may trample, attack, or otherwise cause injury; amusements and entertainment may contain flashing lights, pyrotechnics or loud noises that may cause injury; floors, stairs, escalators, parking lots, grassy areas and other surfaces may be uneven, have holes, or become slippery or otherwise be hazardous due to weather conditions, outdoor weather conditions such as rain, hail, wind, or thunderstorms, all of which may cause injury; spilled beverages or other items may cause injury; spectators and other attendees may engage in unreasonable and belligerent conduct such as fighting or trampling, which may cause injury; flying objects may cause injury; and the presence, movement, or traffic of crowds may cause injury or may lead to a delay in medical attention; and vehicles traveling to/from the events may collide with, hit, or otherwise cause injury, and that these and other risks may lead to injury, illness, or death. - 8. Other restrictions:** No firearms or weapons are permitted on these premises for the College Football Playoff National Championship and related events. The bearer of this credential may not solicit contributions, conduct polling, or distribute literature on the premises. The bearer of this credential hereby grants the Released Parties the right to use throughout the world and in perpetuity, through any media currently existing or hereafter developed the bearer's picture, voice, likeness or name, as the same may be edited, in any broadcast, telecast, print media, promotion or other means on account of any of the College Football Playoff National Championship events for any lawful purpose whatsoever, without compensation or any right of approval. The bearer agrees not to take any action, or cause others to take any action, which would infringe upon CFP's rights. The bearer shall not use the logos of the College Football Playoff, CFP and the College Football Playoff National Championship trophy logo without the express written consent of CFP. The bearer may not interfere in any way with the play of the contest or any other aspect of the event or its telecast.
